**“Because he loves me,” says the Lord,  
“I will rescue him; I will protect him, for he acknowledges my name.” Psalm 91:14**

*The fulfillment of this promise from God was experienced first hand by our group of volunteers who flew into Douala, Cameroon on February 24, 2008 to carry out their mission to build three church roofs, one of them at Mile 8 in memory of Dr. Walter Kerber.*

Upon arrival, they stayed overnight in the Mission House and the following morning the country of Cameroon experienced political and social unrest.



We are thankful that none of our volunteers or the missionaries were injured. The Volunteers stayed one week at the Rest house and then were requested by the Government to return to Canada; but the gifts and funding were left behind. Overall it was a disappointment but GOD’S WAYS ARE NOT OUR WAYS and it was a life changing experience for everyone. Here are some of the comments:

Barry Riddell: I didn't believe it was happening - I thought I was watching TV - especially when the stones were thrown at our vehicle just outside of Douala. I wanted Walter there more than anything else. I knew he would calm us down and keep us positive & trusting.

I am thankful for the people who brought the food to us. This was dangerous for them and they stood in line for hours. We could hear gunshots and chanting. We had bread and I learned a new way to make rice with oil. I became the cook. With all the things I shouldn't have been eating my blood sugar went to normal - a true miracle. GOD was answering your prayers. I was also thankful for the water which was made drinkable - thanks to the knowledge of, Jeff, one of our team members. He was going to introduce this procedure to the Cameroonians.

I don't understand why we were not able to go the villages. But, THANKS to GOD He is totally in charge and HE kept us protected and safe. HE requires our obedience and I will, GOD WILLING, go back next year."

Jeff Brown: On the morning after our arrival, we attempted to leave the city by bus. We travelled only about 10 minutes when we reached a blockade of burning tires and lumber. We were forced to stop and our bus was attacked by a stone-throwing mob that broke windows in the bus. One doctor received minor injuries from flying glass. We quickly retreated to the Baptist guest house where we had been staying.

Apparently, we had accidentally stumbled upon the beginning of a taxi strike against fuel and food prices. The strike quickly escalated into nation wide riots, that saw perhaps 200 or more killed, countless buildings looted and burned, and chaos for many days that saw food and water stocks run out.

When we retreated to the guest house, we found ourselves trapped for about a week. The violence on the streets was severe, and we were afraid for our lives should we step outside. The sound of gunfire echoed throughout the night, and a pall of smoke hung over the city continually.

Jeff continues: We started with a reasonable supply of bottled water. However, given the tropical heat, our supply was soon very low. Our group included a surgeon, a general practitioner, two nurses, and others with medical training. Suddenly, knowledge of the SODIS method of water purification was very interesting to them. As a precaution we purified, using the SODIS method, several litres of water from the tap. However, before we could purify more, the municipal water supply was shut off. Ultimately, we were only without bottled water for a short time. The SODIS method of water purification process needs to be tested; unfortunately the experiments that I wanted to carry out could not be conducted as planned.

A simple purification process is desperately needed throughout Cameroon. The quality of water in rural areas is very poor, with the majority of water drawn from contaminated shallow wells and ponds. Cholera is present in many areas, including non-coastal areas. The quality of urban water sources is only a little better than rural sources. It remains a challenge to the concerned scientist to discover a method that will eliminate all pathogens in an efficacious manner.

**But all was not lost.** The funds left behind enabled our local missionaries to engage workers.

Dr. Palmer writes: "I had time to visit the roof projects, on March 9<sup>th</sup>, at Mile 8 and Babunki. They are making good progress. Mile 8 should have the zinc on in a couple of days.



Yesterday (May 18<sup>th</sup>), we held a dedication at the Berean Baptist Church, Mile 8, Bamenda. The occasion was the dedication of the roof of the church building and also to remember Dr. Walter Kerber, who died suddenly in May, 2007, founder of the For We Care Outreach Network Society (FWC), who has been so important in assisting us with many of our church building projects.

We had a great service, recognizing the hard work of the congregation and the contribution that Dr. Kerber's family and the FWC building team had made to get the project to the level it has reached.



Churches take a long time to complete here, but they become useful after the roof is completed. This building was started in 2003, with the walls completed after 3 years, then the structure stood for 2 years before there was any opportunity to work on the roof. The FWC building team, lead by Ron Klettke, came out in February of this year to put up the roof on the church along with two other church roofs. Unfortunately, the team was unable to get to the Northwest Province due to the unrest associated with the strikes. A team from our Projects Department was able to complete the roof with funding provided by FWC.

Another Team left for its project sites in Florianopolis, BRAZIL from February 16<sup>th</sup> to March 14<sup>th</sup> 2008. Byron, & Julie Reichel, Cornie Brandt & Jeff Reichel report:

We spent warm days in Brazil. *Ron & Alana had again warmly welcomed us; they helped on a daily basis with translation and arranging the work.* The time in Florianopolis was divided between the Estiva drug centre and the new building at the CETE orphanage/daycare site. Rain held up completion of the roof on the dorm at Estiva but Byron, Jeff, Cornie and Julie did finish the electrical in the building and did some electrical repairs in the barn. At CETE the building was ready for electrical and they had some of the material so the guys did the rough in. Julie decided that the daycare nursery across the street was a better jobsite.

We went with Ron & Alana the first week to the new church plant they are involved in and agreed to spend

our first Saturday painting the meeting area for them. We were encouraged on the hour+ drive to get there because it was sunny – but then the clouds came up and we ended up repainting because the rain just washed the light blue down the road. We were a small group made welcome by the boys, leaders from CETE, Pastor & Mrs. Jonas, and the familiar faces that we knew from before. Ron asked for electrical help on a house that a family with a handicap child was planning to move into. The house had been sitting empty and someone stripped all the wire. It needed to be rewired.

The urban project areas are not in our comfort zone. It left us grateful for the laws and morals of our land. Our last two days in Floripa were spent mostly at the beaches. The best part of a February trip was the warmer ocean water and sand. Cornie headed for home and Byron, Julie and Jeff went to the Chain of Love. Mark Kanwischer and Chris Kidd had a few jobs for Byron and Jeff at the centre and also at the Baptist Seminary in Puerto Alegre. It was a good experience to meet the children and visit with Chris and Ingrid Kidd. Our group bonded with prayer, work and laughter. Friendships made this way will never fade.

## Upcoming Ministry Opportunity

### **Brazil – November 8<sup>th</sup> to 29<sup>th</sup>, 2008**

We will be working at the CVM Drug Rehab Center for drug-addicted boys and at their Orphanage. There are ten "Care-givers" already signed up. The debriefing of our Care-givers, on this ministry trip, will take place in the southern part of Brazil. Our sign-up cut-off date will be sometime in September, in order to make our seat reservations. We expect each Care-giver to raise approximately \$4,000 to fund this and other ministries. Whether or not you plan to become a November 2008 Team member, we would like to encourage you to seriously consider your participation in this fundraising effort and to start doing so now as FUNDS are needed prior to our departure so that the local contractors can start putting down the footings for the new dorm.

## What We Do - How We Do It

### **Can Continue or Become a Vital Participant**

#### **Mandate**

The mandate of the Society includes and currently focuses on serving the underprivileged, relieving poverty, and to create or enhance facilities through construction projects such as shelters, schools, churches and hospitals, in "developing nations".

#### **Resources and Manpower**

To accomplish its mandate, the Society benefits from two kinds of volunteer "Care-givers": those who either help raise funding or accept assignments as members of a Mission Team ("Team"); and some that do both.

The Cash resources are used to acquire materials and equipment for specific projects, hire the necessary local labourers, and pay for the transportation and accommodation expenses of the Team.

Oversees Team members provide on-site physical labour as well as supervision and training of local labourers who have been hired with funds provided by the Society. They may also be involved in evangelistic efforts such as the showing of the Jesus film.

The Board or its designees assembles Teams by seeking and appointing as many volunteers as funding permits; and, being an effective Fundraiser shall not be a pre-requisite to such an appointment.

#### **Making the Team**

Team members are expected to be physically able to carry out their volunteer assignments, to have the specific skills that may be required at a given project, and be generally healthy and immunized against diseases that are prevalent in the destination countries.

Prior to leaving on their assignments and subsequent to their return, Caregivers are expected to participate in the Society's fundraising efforts to replenish its resources so that other Ambassadors may have opportunity to offer their time and skills in the future.

#### **Training and Debriefing**

Team members must set sufficient time apart for the duration of the on-site assignment plus a few days of debriefing at the end of the project at a location "en route" before returning home. This debriefing is important in order to "rest up" and document any specific experiences that may benefit future teams as well as creating presentation formats and story boards to assist in fundraising efforts. This helps our Care-givers to become more qualified in representing the For We Care Outreach Network Society on an ongoing basis.

## Becoming a Member of the For We Care Outreach Network Society

As you can tell from the forgoing, it is our desire to establish long-term relationships with everyone that supports our ministries, whether it is through volunteer services or financial support, or both.

With that in mind, we are extending to all of our financial donors the eligibility to become voting members of the Society (corporate donors may designate an individual to hold the voting right). To make it easy, we have granted immediate membership on an opt-out basis to every individual and corporate Donor to date. Please complete the attached Membership Instructions form so that our database information can be updated as per your wishes. At present, Membership is subject to a minimum annual donation of \$120, the Minimum Annual Contribution (MAC) which can form part of any donation. Our Bylaw 2 reads:

### 2. Membership

1. Any resident of Canada who financially supports the Society becomes a Member of the Society.
2. No Membership Fee shall apply; however, the Board may, from time to time, establish a Minimum Annual Contribution ("MAC") for Membership which shall be receiptable for Income Tax purposes. Any such MAC does not confer upon the Member any personal benefits or privileges upon the Donor Member other than the right to attend meetings and vote as provided herein.
3. Each Member is subject to any Membership and/or Meeting guidelines, conditions and responsibilities established by the Board from time to time.
4. Unless otherwise agreed upon by the Board, on a case by case basis, Membership is for an initial term ending at the conclusion of the next Annual Meeting.
5. Even though an applicable MAC has been received and Membership has been conferred upon the Donor, the Donor may opt out of Membership at any time.
6. Membership may be cancelled for any cause or reason which the Board may deem reasonable, upon vote by the Board.
7. Members in good standing shall have Voice and Vote at meetings of the Membership.
8. Members may attend any meetings of the Board, as participating observers, and as such have Voice but no Vote.
